DOH-St. Lucie joins a cohort of over 450 local health departments across the country that have been distinguished for excellence in preparedness through PPHR, either individually or as part of a region.

These standards align with federal government requirements and other national best practices.

PPHR recognition also requires health departments to collaborate with their state, local, and community partners to develop plans that account for all the constituents in their jurisdictions. "Local health departments play a critical role in preparing for, responding to, and recovering from public health emergencies," said Dr. William Barnes, NACCHO Interim Executive Director & Chief Program Officer. "NACCHO commends St. Lucie County for being a model of public health emergency preparedness."
