**St. Lucie County, FL** – The Florida Department of Health in St. Lucie announces the launch of a wellbeing survey, as part of a larger Community Health Assessment (CHA) conducted every 3-5 years to identify strategies to improve community health.

“In our effort to provide direction to organizations trying to make a difference in health outcomes, we are seeking feedback from residents aged 18 and over on their perceptions of health and wellbeing in our community,” said Clint Sperber, Administrator and County Health Officer for the Florida Department of Health in St. Lucie.

Survey responses are confidential and will be used to develop a community health improvement plan by the end of the year with local organizations addressing issues residents are most concerned about. “Through collaborative efforts with our Healthy St. Lucie partners, we can continue building a culture of health where all residents have the best opportunity for health and wellbeing,” said Jennifer Harris, Director of Community Health Promotion for the Florida Department of Health in St. Lucie.
